FIRST AID

If skin irritation occurs: Get medical advice or attention.

IF SWALLOWED: Rinse mouth, Do not induce vomiting. Unless advised otherwise by a poison control center or doctor, if able. Do not give anything by mouth to an unconscious person. Call a poison center, doctor, chemical manufacturer, importer, or distributor to specify the appropriate source of emergency medical advice if you feel unwell.

IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

GENERAL INFORMATION

ONSIDE KICK™ tank cleaner is formulated to eliminate residues from mix tanks. Thorough cleaning of spray equipment with **ONSIDE KICK™** before changing to the next pesticide prevents previous tank mix solutions from affecting future spraying. **ONSIDE KICK™** has an extremely alkaline pH and helps solubilize acid active ingredients more efficiently.

- Reduces carryover of actives that can injure sensitive turf and ornamentals
- Extends life of seals and other soft parts by removing actives and residues and other corrosive materials

- Cleaning pesticide actives and other residues out of mix tanks and spray equipment

DIRECTIONS FOR USE

For small tanks such as backpack sprayers: Fill the sprayer with a small amount of water. Add about 1 ounce of **ONSIDE KICK™** for each gallon of water. Shake sprayer to cover all surfaces several times. Pour out water. Repeat, if needed. Rinse several times with clean fresh water until all signs of cleaning agent are gone.

For large tanks: Use about 1 quart of **ONSIDE KICK™** per 100 gallons of water. Hard-to-eliminate residues, such as 2,4-D or dicamba may require increased amounts of **ONSIDE KICK™** or repeated rinses or both in order to completely eliminate these tricky residues.

Add rinse water then tank cleaner at an amount adequate for cleaning. Turn on circulation. Continue circulation for 10 to 15 minutes. As prescribed by the equipment manufacturer, clean the booms, hoses and other outer areas for several minutes. Drain the system. Follow with several thorough rinses. Complete rinsing is essential before starting the next tank mix.

HARD TO CLEAN RESIDUES AND RINSATE TESTING: Some pesticides are difficult to clean even with thorough procedures. Some residues, such as those from 2,4-D and dicamba, may be extremely hard to remove. Carryover of these actives could injure certain plants and sensitive ornamentals, if not thoroughly removed.

STORAGE AND DISPOSAL

STORAGE: Store locked up. Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
